Sub: Proposed placement of equity shares of face value of Rs. 10 each ("Equity Shares") through a qualified institutions placement (the "Issue") under Chapter VIII of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2009, as amended ("SEBI ICDR Regulations") and Section 42 of the Companies Act, 2013, by CESC Limited (the "Company") to qualified institutional buyers as defined under Regulation 2(1)(zd) of the SEBI Regulations ("QIBs").

- 1. Authorising the opening of the Issue from 28 October, 2014.
- 2. Approving and adopting the preliminary placement document dated 28 October, 2014.
- 3. The relevant date for the purpose of this Issue in terms of Regulation 81 (c) (i) of the SEBI ICDR Regulations is 28 October, 2014 and accordingly the floor price in respect of the aforesaid Issue, based on the pricing formula as prescribed in under Regulation 85 (1) of the SEBI ICDR Regulations is Rs. 677.84 per Equity Share (the "Floor Price"). A discount of up to 5% on the Floor Price may be offered by the Company to investors in the Issue, at its discretion.

In relation to the Issue, we have filed the preliminary placement document dated 28 October, 2014 with your office today.

Kindly take the above notification on record and the same may be treated as compliance under applicable clause(s) of the equity listing agreement.
